# **ESSA Reauthorized**

The Every Student Succeeds Act (ESSA) was signed by President Obama on December 10, 2015. This bipartisan measure reauthorizes the 50-year-old Elementary and Secondary Education Act (ESEA), the nation's national education law and longstanding commitment to equal opportunity for all students

# **ESSA Purposes**

Data is used to facilitate the identification of performance gaps and strategic planning for improvement in all student groups that meet the minimum n-size of 20 students. New Jersey's measure of student success and school quality are captured in indicators that include: academic achievement on statewide assessments, academic growth, graduation rate, chronic absenteeism, and the new indicator of English language proficiency growth.

### **ESSA Profile Data: Participation Rates**

In English Language Arts we are not meeting standard for every subgroup except Black/African and Asian.

In Math we are not meeting standard for every subgroup except Black/African, Asian and English Language Learners.

#### **ESSA Profile Data: Academic Achievement**

In Language Arts "Met Target" in 8 of 9 subgroups and "Met Target with Confidence Interval' in the remaining subgroup (Students with Disabilities)

In Math "Met Target" in 8 of 9 subgroups and "Met Target with Confidence Interval' in the remaining subgroup (English Language Learners).

## ESSA Profile Data: English Language Arts Academic Progress

In English Language Arts earned score of "Met Target" in every subgroup except for English Language Learners where it earned a rating of "Exceeds Standard."

### **ESSA Profile Data: Math Academic Progress**

In Math earned score of "Exceeds Standard" in every subgroup except for Two or More Races and Students with Disabilities where it earned a rating of "Met Target."

#### **ESSA Profile Data: Graduation Rate**

**Four Year Graduation Rates**: Not meeting target for Schoolwide (-1.5%), White (-1.1%), Economically Disadvantaged (-1.6%) and Students with Disabilities (-11.5).

**Five Year Graduation Rates**: Long Term Goal met in each subgroup except Students with Disabilities (-5.7%)

#### ESSA Profile Data: Chronic Absenteeism

In the area of School Quality/Student Success, which examines
Chronic Absenteeism, we "Met Target" for every subgroup
except Students with Disabilities and English Language Learners.
Every subgroup except Two or More Races reflected double digit
decreases in student absences

As a District, met "Confidence Interval" in this area. We earned a growth of 45.9% with a target of 56.6%
